On 18 September 2019, **Mr Agustín Carstens, General Manager of Bank for International Settlements (BIS)** shared his views on the topic "The Road to the New Normal: from Financial Crisis to Fintech Challenges" with around 60 AoF Members and senior management from various fields of finance in Hong Kong. Mr Carstens had a candid conversation with participants sharing his experiences working in various positions in his career, his insights on the Global Financial Crisis, financial system and Fintech, as well as the latest development of the BIS Innovation Hub project.







A Fireside Chat with **Mr Charles Kaye, Co-Chief Executive Officer of Warburg Pincus**, was held on 25 September 2019. Mr Kaye shared his insights on "Growth Investing: How Growth Investing Fits into the Private Equity Industry" with AoF Members and senior management from various fields of finance in Hong Kong. Mr Kaye had an in-depth sharing with participants about the investment philosophy of his firm, his views on different types of growth investing strategies, and the future growth opportunities.



The Academy hosted a lunch for **Mr Timothy Geithner, President of Warburg Pincus and former Secretary of the U.S. Department of the Treasury**, on 21 November 2019. Mr Geithner shared his insights with AoF Members on a number of issues, including the global economy, US monetary policy and US-China relationship.









On 25 November 2019, Dame Minouche Shafik, Director of London School of Economics and Political Science and former Deputy Governor of the Bank of England, spoke on the topic "Optimism in the Past, Pessimism in the Future?" with AoF Members and senior management from various fields of finance in Hong Kong. Dame Minouche had a candid conversation with participants, sharing her views on the challenges we are facing in the global context and suggesting possible solutions to them. Dame Minouche also emphasised the role of social contract in driving economic and social development worldwide.
